HyEnergy® PROJECT

The Company first commenced discussions with the State government on appropriate tenure for the HyEnergy® project in May 2021. Since that time the Company has been in continuous dialogue with various departments and ministers, as yet there is still no satisfactory outcome from these engagements.

The Company has limited all work on the HyEnergy® project and will not recommence until such time as there is a clear path forward for the project.

The Company is investigating pathways for the shares of the Company to once again be tradeable on the ASX.

CORPORATE

Cash balance and Related Party Payments

At the end of the quarter, the Company had a cash balance of \$10.16 million.
